RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT.

RELEASE AGREEMENT:

To: Jans LTD and its entire staff (hereinafter collectively referred to as the 'Releasees').

Assumption of Risks

I am aware that Nordic Skiing involves many risks, danger and hazards including, but not limited to: icy conditions; sudden falls; exposed branches, rocks, and debris; varying track conditions; variable and difficult conditions; ponds, rivers, streams and standing water; collisions with other persons or animals; hazard or obstacles during times of grooming and track repair; snowmobiles on the track; failure to keep oneself on the track; negligence of other skiers and snowshoers; and the negligence on the part of the releasees, including the failure on the part of the releasees to take reasonable steps to safeguard or protect me from the risks, dangers and hazards referred to above. I am also aware that the risks, dangers, and hazards referred to above exist throughout the ski area and that many hazards are unmarked. I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS, AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

Release of Liability, Waiver of Claims and Indemnity Agreement:

In consideration of the Releasees accepting my application for a Season Pass and permitting my use of the Cross Country Track, retail location, and other ski facilities (hereinafter 'the facilities'), and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree as follows:

- 1. TO WAIVE AND ALL CLAIMS that I have or may have in the future have against THE RELEASEES, and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer, as a result of my use or my presence on the facilities DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER ANY APPICABLE OCCUPIERS' LIABILITY LEGISLATION ON THE PART OF THE RELEASEES, AND ALSO INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE;
- 2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of or personal injury to any third party, resulting from my use or presence on the facilities;
- 3. This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;
- 4. This agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of Summit County, Utah and no other jurisdiction;
- 5. Any litigation involving the parties to the Agreement shall be brought solely within Summit County, and shall be within the exclusive jurisdiction of Summit County, Utah;
 - In entering into this Agreement I am not relying upon any oral or written representations or statements made by the Releasees with the respect to the safety of skiing other than what is set forth in this Release Agreement.
 - The Season Pass, issued to the Passholder is the property of White Pine Touring and Jans LTD, is not transferable, not for resale and is revocable for misconduct or breach of any Trail etiquette policies set forth by the Releasees. White Pine Nordic Center retains the right to seize a pass in the event of 'less than acceptable behavior' and prohibit that individual or family from the use of White Pine Nordic Center Trails.

I HAVE READ AND UNDERSTAND THIS RELEASE AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVE MAY HAVE AGAINST THE RELEASEES.
